#### 12.1 Superintendent's Report

Superintendent Dr. Nellie Meyer thanked the MVLA Education Foundation for hosting the Leadership Circle breakfast meeting. A panel discussion which included cabinet members, was conducted during the breakfast meeting.

Dr. Meyer shared that during recent school visits, at Los Altos they observed students in the lab working to extract DNA to look for markers of Huntington's Disease. In another classroom, students were engaged in their Culinary Arts class. Dr. Meyer noted that a new Culinary Arts building will be constructed at Los Altos High School.

Dr. Meyer reported that since the last Board meeting:

- Stanford hosted their speech & debate invitational at which the MVLA team took many awards
- Freestyle students gave a presentation at the computer museum highlighting their projects.
- Construction at the high schools has begun.
- The speaker series event, "The Fuzzy and the Techie: Why the Liberal Arts will Rule the Digital World", by Scott Hartley, was held at Mountain View High School. Dr. Meyer shared highlights of the presentation.
- Writer's Week was held at Los Altos High School.
- In Civic Engagement, she listened to Mountain View's mayor and heard her story about how she came to be in government.
